PRACTICAL CISA TRAINING

Course Description

With a growing demand for professionals possessing Information systems (IS) audit, control and security skills, CISA has become a preferred certification program by individuals and organizations around the world. This practical hands-on CISA training will enable participants to acquire marketable IS audit and security skills and pass CISA exam at their first attempts. As part of the training package, participants will get an opportunity to conduct real IS audit assignment(s) in a real business environment under supervision of our experienced certified IS auditors.

Course Contents

CISA candidates are taken through intensive training on the following five modules:

- Module 1—CISA: The Process of Auditing Information Systems
- Module 2—CISA's Role in IT Governance
- Module 3—CISA's Role in Systems and Infrastructure Life Cycle Management
- Module 4—CISA's Role in IT Service Delivery and Support □ Module 5—CISA's Role in Protection of Information Assets.

Training Methodology

We embrace holistic approach which is geared towards exploiting all the aspects for the candidates to pass CISA exam at their first attempts.

In particular, this practical training program will be conducted in three Stages:

Stage I: Class room training : At the beginning of each training module, participants will be assessed to measure their level of knowledge and skills. They will then be taught theoretical and practical aspects as per CISA curriculum. This will be done through face-to-face interactions with experienced certified facilitators. The training will be participatory and will include sharing of experiences, Case studies, handouts, group discussions, and Video shows. Comprehensive set of

materials which include ISACA CISA review manual, Exam databases and supplementary materials to supplement the content areas in ISACA manual will also be provided. Participants will also get an opportunity to access real information systems and infrastructure components relating to specific topic under discussion. Moreover participants will be subjected to a series of mock exams to assess their progress and understanding of the key concepts being taught at the end of each module.

Stage II: Real Information System(IS) Auditing : Under the supervision of experienced certified IS auditors, the candidates will get an opportunity to conduct real IS audit assignment(s) in accordance with IS audit standards , guidelines and best practices. Participants will get access to the real business environment. Our ICT laboratory is equipped with among other things: a Network infrastructure with a Firewall, Intrusion Prevention System, , VPN technology, Biometric System, Cisco routers and Switches. The available business Applications include ERP system(Sage 31000) , Banking Software, PBX system, Academic Management System, and computer forensic software and tools

Stage III: Mock Exam: Finally overall mock exam simulating a real CISA exam will be given to participants

Training Facilitators and facility :

- Our faculty members are practicing professionals representing prominent companies in Tanzania. They all possess specialist certifications in their areas of specialization including CISA, CISM, CISSP, CEH, CPA(T), and CIA . They also possess relevant academic qualifications such as PhDs, and MSCs and MBAs.
